#### 第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時,該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

#### 第 53(2)條/ Section 53(2)

如某人於某日期訂立臨時買賣合約,並於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則擁有人必須在該日期後的8個工作日內,簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

#### 第 53(3)條/ Section 53(3)

如某人於某日期訂立臨時買賣合約,但沒有於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則-(i)該臨時合約即告終止; (ii)有關的臨時訂金即予沒收;及(iii)擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

- (3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第 8 條及附二第 2 部的計算得出的。
  The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.
- (4) <u>(i) 支付條款 Terms of Payment</u>:

買方於簽署臨時買賣合約時須繳付相等於售價之 5 %之金額作為臨時訂金,其中 HK\$500,000 之訂金必須以銀行本票支付, 「抬頭請寫『羅文錦律師樓」,餘額可以支票支付「抬頭請寫『羅文錦律師樓」。

Those who purchased the first six single unites on or before  $15^{th}$  day of November 2013 shall have the right to purchase any one of the residential parking spaces on the  $2^{nd}$  and  $3^{rd}$  floors of Eugene Terrace at the value of HK\$1.00.

# (iv) 誰人負責支付買賣該項目中的指明住宅物業的有關律師費及印花稅 Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the development
